
Your task is to write an essay that you will read at the Mock Council Meeting. In your essay you are expected to highlight issues within the Graytown Division that you think need urgent attention.

## Trouble in Graytown

On Friday, the Sweeton Municipal Corporation (SMC) and the police carried out another operation to remove street vendors from South Avenue in the Graytown Division.

The Mayor of Graytown, John Brown said the vendors were blocking sidewalks and streets. This has resulted in pedestrians having to walk in the middle of the streets. The Mayor also stated that store owners constantly complain about the piles of garbage left by vendors each day.

The Mayor informed the news team that the Sweeton Municipal Corporation is able to make by-laws and regulations that affect how markets are operated. In addition to controlling public vending, Municipal Corporations are also responsible for the maintenance of markets, parks and public cemeteries.

He further explained that the Municipal Corporation has provided more than enough space for vendors in the market on Clarke Street. There are also toilets and other facilities provided for the vendors' convenience there.

Mr. Brown also said he was willing to meet with the vendors to work out solutions to the problems.

In response to vendors' complaints about high market fees, beginning Wednesday, January 22, 2022 the Sweeton Municipal Corporation will reduce the market fees by thirty percent (30%). The Municipal Corporation is now finalizing plans for the construction of a bus park beside the Clarke Street Market. They also intend to repair broken stalls at no cost to the vendors as well as commit to making regular market inspections and repairs.




